Instructions for Order Form 501-LLC

Limited Liability Company BIENNIAL Declaration of Members and Managers

California law requires all corporations, limited liability companies and common interest development associations to update the records of the California Secretary of State on the anniversary month of registration by filing a statement of information.

Section references are to the California Corporations Code unless otherwise noted.

Do You Have to File?

Statutory filing provisions are found in California Corporations Code Section 17060. Should the Limited Liability Company fail to file their State of Information by its due date, they will be assessed a **penalty** in the amount of **\$250** which will be assessed by the California Franchise Tax Board. (California Corporations Code Section 17651(b) and 17653; Revenue and Taxation Code Section 19141).



Failure to file your Statement of Information may cause the Limited Liability Company to become SUSPENDED. While the LLC is under Suspension status the following will be affected:

- Lose the right to conduct business
- Lose the right to retain entity name
- Lose the right to answer lawsuit
- Leaves the LLC's properties vulnerable

What If You Can't File On Time?

Domestic and Foreign California Limited Liability Companies are required to file or cause to be filed a Statement of Information with the California Secretary of State within 90 days after filing of its original Articles of Organization or Application of Registration and annually thereafter during the applicable filing period.

The application filing period for a Limited Liability Company is the calendar month during which its original Articles of Organization or Application of Registration were filed and then immediately preceding five calendar months. A Limited Liability Company is required to file their Statement of Information even though it may not be actively engaged in business at the time their statement is due. Changes to the Statement of Information which was previously filed can be made by filing a new Statement of Information and completed in its entirety.

General Instructions

Part 1. Business Name. The legal name of your Limited Liability Company as it appears on your Articles of Organization.

Part 2. Business Address. The physical business address, must not be a P.O. Box.

Part 3. Foreign Entity. If your LLC is a Foreign Entity, provide the State or Country where formed.

Part 4. Business Addresses.

- a. Mailing Address. Your Mailing Address if different than (2) your business Address
- b. Street Address. Your California address if your 4(a) mailing address is not in California.
- Part 5. Member(s) or Manager(s). List your Member(s) or Manager(s). If more than one, please list all along with addresses on a separate sheet and attach.
- Part 6. Type of Business. Describe the type of business or service(s) of your LLC.
- Part 7. Labor Judgement. Check YES or NO to disclose if any Member or Manager have an outstanding final judgement issued by the Division of Labor Standards Enforcement or a court of law, for which no appeal is pending, for the violation of any wage order or provision of the Labor Code.
- Part 8. Service of Process. Must provide full name and address of Agent for Service of Process, either an individual or a Registered Agent Corporation (Must not be the corporation listed in Part 1).

Part 9. Chief Executive Officer. If elected or appointed, please include the full name and address of your CEO.
